BACKGROUND:

The Yolo Habitat Conservancy entered into an Agreement with Urban Economics on March 17, 2025, to prepare a five-year periodic assessment and adjustment of fees as required by Chapter 8 of the Yolo HCP/NCCP. This original Agreement expires December 31, 2025. The First Amendment to this Agreement would add \$5,000 to the Agreement amount, thereby increasing the total contract amount to a total of \$55,000, for Urban Economic to provide Conservancy staff with additional fee assessment support and would extend the term of the Agreement to December 31, 2026 to both provide these services and to complete the five-year periodic assessment as outlined in the original scope of work.

BACKGROUND:

The Yolo Habitat Conservancy (YHC) entered into an Agreement with the Cache Creek Conservancy (CCC) on March 17, 2025, to conduct a northwestern pond turtle survey on and within the proximity of conservation lands enrolled in the Yolo HCP/NCCP reserve system along Cache Creek, identify and map native plant populations within the Cache Creek watershed that may be suitable sources of plant material for propagation for future restoration projects, and provide other monitoring and restoration assistance as directed in writing by YHC. In June 2026, YHC staff wrote a grant proposal requesting funding from the National Fish and Wildlife Foundation (NFWF) Monarch Butterfly and Pollinators Conservation Fund to conduct pollinator habitat enhancement, restoration, and education activities on existing and candidate Yolo HCP/NCCP reserve system sites. As part of this effort, YHC staff collaborated with CCC staff on the identification of sites and specific habitat enhancement and restoration needs within the Cache Creek corridor. YHC was awarded a 2-year, \$260,000, grant from NFWF with the CCC identified as a sub-grant recipient. The First Amendment to this Agreement would add \$83,000 to the Agreement amount thereby increasing the total contract amount to a total of \$102,000, would add a task to the scope of services to conduct activities specific to implementing the NFWF grant-funded project, and extend the term of the Agreement to December 31, 2027 to be consistent with the implementation period of the NFWF grant.

BACKGROUND:

The Conservancy entered into an Agreement with Alford Environmental, LLC on May 19, 2025, to provide Yolo HCP/NCCP implementation and administrative support services during fiscal year 2025-2026. The scope of services in the Agreement include serving as the Interim Executive Director until an Executive Director is hired, with the expectation that the hiring of the Executive Director would occur within one to three months of the start of the 2025-2026 fiscal year.

On March 17, 2025, the Yolo Habitat Conservancy Board determined that it wished to continue to maintain a Memorandum of Understanding (MOU) with Yolo County (County) to provide administrative and other support services, including the provision of an Executive Director staff position. This decision was re-iterated by the Conservancy Board on May 19, 2025 with the approval of a Sixth Amendment to the MOU with the County to provide administrative services, including Executive Director services. This Sixth Amendment to the MOU was approved by the County Board of Supervisors on July 8, 2025. County staff have taken steps to re-classify an existing County staff position to fulfill the role of a full-time Yolo Habitat Conservancy Executive Director; however, this position is currently vacant. County staff have recently stated that they anticipate releasing a solicitation for applicants to fill the Executive Director position in January 2026. The proposed First Amendment (Attachment A) acknowledges that the Interim Executive Director services provided by

Alford Environmental, LLC have extended beyond what was identified in the Agreement and increases the contract amount accordingly.

1. Authorize the Interim Executive Director to execute a Memorandum of Understanding with Yolo County for conservation and restoration activities at the Haller Muller property (Attachment A)

BACKGROUND:

The Haller Muller property is owned by Yolo County (County) and located within the Cache Creek corridor (Attachment B). The Conservancy Board approved the inclusion of the Haller Muller property as a candidate Yolo HCP/NCCP conservation easement site on September 16, 2024. In addition to the site being identified as a candidate conservation easement site, the Conservancy's Science and Technical Advisory Committee has also identified the site as being suitable for habitat restoration. The attached Memorandum of Understanding (MOU) between the County and the Conservancy provides a framework under which the Conservancy will coordinate with the County to complete the establishment of a Yolo HCP/NCCP conservation easement and conduct habitat restoration and enhancement activities, including the planting and transplanting of elderberry shrubs as-needed to mitigate for potential impacts to valley elderberry longhorn beetle (VELB), on the property. The MOU also authorizes site access to Conservancy representatives and contractors as necessary to complete due diligence activities required by the HCP/NCCP. Conservancy staff recommend the Board approve the general form of the attached MOU and authorize the Conservancy's Interim Executive Director and Legal Counsel to review and approve minor edits that the County may provide. Any edits proposed by the County that increase the Conservancy's costs or liabilities will be brought back to the Conservancy Board for approval.

WHEREAS, on December 29, 1998, the County and Teichert Land Company recorded a habitat conservation easement ("Original Conservation Easement", DOC-98-0038629-00) on 121 acres of land along Cache Creek and within the Cache Creek Area Plan ("CCAP") boundaries, located within the 124.157-acre property currently identified as the Haller Muller site (the "Property");

WHEREAS, on July 18, 2024, the Teichert Land Company transferred ownership of the Property to the County as documented in the Grant Deed recorded on July 18, 2024 (DOC-2024-0012427);

WHEREAS, on December 20, 2014, the Yolo County Board of Supervisors adopted a resolution (Resolution No. 14-126) supporting a conservation partnership with the Yolo Habitat Conservancy in connection with implementation of the Yolo Habitat Conservation Plan and Natural Community Conservation Plan ("Yolo HCP/NCCP");

WHEREAS, the partnership envisioned in Resolution No. 14-126 included enrolling sites in the Yolo HCP/NCCP reserve system with the establishment of Yolo HCP/NCCP habitat conservation easements on between 250 and 660 acres of County-owned land within the area covered by Cache Creek Area Plan ("CCAP"), including associated management and related activities;

WHEREAS, the Yolo HCP/NCCP was subsequently approved and is now being implemented by the Yolo Habitat Conservancy; and

WHEREAS, the purpose of this MOU is to confirm the County and the Conservancy's mutual interest in upgrading the Original Conservation Easement with a habitat conservation easement that meets the standards of the Yolo HCP/NCCP ("HCP/NCCP Conservation Easement") and allowing the Conservancy to conduct habitat restoration activities on the Property, and to provide a revocable license for Conservancy staff and contractors to access the Property to conduct due diligence activities as required prior to finalizing and recording the HCP/NCCP Conservation Easement.

NOW, THEREFORE, the Parties hereby agree as follows:

AGREEMENT

1. Purpose. The Conservancy desires to replace the Original Conservation Easement on the Property with a HCP/NCCP Conservation Easement and to obtain the right to use portions of the Property as habitat restoration areas and for the relocation of elderberry shrubs to be transplanted by third parties ("Transplanting"). The Transplanting is anticipated to include additional plantings of elderberry shrubs and native plants, along with all maintenance reasonably necessary to ensure the successful establishment of such plants. The County is amenable to providing, through a revocable license arrangement, all access to the Property that may reasonably be required for Conservancy representatives and third parties to access the property for the purposes of completing due diligence activities for the HCP/NCCP Conservation Easement and to identify areas suitable for future plantings of elderberry shrubs. The County is also amenable to working in collaboration with the Conservancy to provide for permanent conservation and management of the site through a habitat conservation easement.

As set forth in more detail below, the access rights and related rights set forth above are subject to the terms set forth herein, including but not limited to the indemnity, defense, and waiver of liability provisions. This MOU shall take effect on the date that it is fully executed by the Parties (the "Effective Date").

2. Permitted Use of Property. The Conservancy and its authorized designees (subject to Section 3, below) may conduct reasonable and customary due diligence activities on the Property as deemed appropriate by the Conservancy, in its reasonable discretion, to establish the HCP/NCCP Conservation Easement as part of implementation of the Yolo HCP/NCCP. The Conservancy and its authorized designees, including but not limited to biologists and other contractors retained by the Conservancy or any participant (including special participating entities) in implementation of the Yolo HCP/NCCP, may also access and use portions of the Property to identify areas suitable for habitat restoration and Transplanting and to transport equipment, personnel, and materials necessary to implement the habitat restoration and Transplanting. This right of access for the purpose of due diligence activities necessary prior to finalization of the HCP/NCCP Conservation Easement and all activities associated with habitat restoration and Transplanting prior to recording of the HCP/NCCP Conservation Easement shall constitute a license subject to revocation at any time by the County Administrator or its authorized designee(s). The Conservancy's rights under the license include the right to access and perform all work required to sustain the plants and any other restoration project components over time, including for purposes of invasive weed control, erosion reduction, and other reasonably related purposes. Conservancy shall not store equipment or materials on the Property or engage in any other use not expressly set forth herein without written approval of the County Administrator or its authorized designee.

The license shall be limited in scope as set forth in this Section 2 and shall exist until terminated by County or until the HCP/NCCP Conservation Easement is recorded on the Property. Once the HCP/NCCP Conservation Easement is recorded on the Property, the HCP/NCCP Conservation Easement shall include all necessary access rights and the associated site-specific management plan, together with the Conservation Easement, shall dictate the permitted uses and restrictions of the Property.

- 3. Contractors and Subcontractors. Third parties, including but not limited to one or more contractors and possibly subcontractors retained by the Conservancy or entities that receive take authorization through the Yolo HCP/NCCP, are expected to carry out the work described generally above. The Conservancy and/or County, as appropriate, will cooperate to provide such third parties access to the Property upon their receipt of an executed version of the attached certification evidencing their acknowledgement and consent to be bound by all of the terms and conditions of this MOU (Attachment A). Nothing in this MOU shall be interpreted to modify the rights and obligations of the Conservancy and such third parties under other agreements entered into for purposes of completing the work described herein.
- **Release.** In consideration for allowing the Conservancy to use the Property as set forth in Section 2, above, the Conservancy releases from liability and waives any right to sue the County, its officers, employees, contractors, and agents ("Released Parties") for any claim, demand, or action, including negligence, for any injury, illness, death, property damage, loss or expense, including attorneys' fees, the Conservancy or any of its employees, agents, contractors (including all subcontractors), officers or volunteers may suffer or that may result from the Conservancy's use of the Property, wherever or however such loss may occur.
- 5. <u>Assumption of Risk</u>. The County makes no representations or warranties as to the suitability or safety of the Property for the Conservancy's intended use. The Conservancy understands the risks associated with its use and any activity incidental to the use, and that these risks may at times result in injury, illness, death or property damage. The Conservancy acknowledges that these risks include negligent emergency or medical care. Nonetheless, the Conservancy assumes all risks, whether known or unknown, of using the Property or any activity incidental to use of the Property.
- 6. <u>Indemnification</u>. The Conservancy agrees to indemnify, defend, assume all liability for and hold harmless the Released Parties from all actions, claims, losses, suits, penalties, obligations, liabilities, damages to property, environmental claims or injuries to persons or property, which may be caused by the Conservancy's activities arising out of or in connection with the Conservancy's use of the Property, whether such activities or performance of those activities is by the Conservancy or anyone directly or indirectly employed or under contract with or volunteering for the Conservancy, and whether such damage or claim shall accrue or be discovered before or after the Conservancy's use of the Property is complete. The Conservancy specifically, and not by way of limitation, agrees that it shall be responsible for the repair, maintenance and cleanup of any condition caused by its use of the Property.
- 7. Property Conservation and Management. Subsequent to the execution of this MOU, the County Administrator or their authorized designee(s) shall cooperate in good faith with the Conservancy Executive Director or their authorized designee(s) to allow for the completion of due diligence activities and to take all steps necessary to finalize and execute (upon subsequent approval of their respective governing boards, if necessary) a habitat conservation easement of perpetual duration on the Property. The County Administrator and Conservancy Executive Director are authorized to coordinate with County Counsel and Conservancy Counsel to make minor modifications as needed to the draft Conservation Easement (Attachment B) provided

such modifications are consistent with the purpose of this MOU, as set forth in Section 1, above, and take any further actions necessary to enroll the Property into the Yolo HCP/NCCP reserve system. The Conservancy shall bear all costs (excluding County staff time) associated with the preparation and recording of the habitat conservation easement and any related documents, such as a management plan.

At all times subsequent to execution of this MOU, the County shall avoid any activities that may impair or otherwise jeopardize the successful completion and maintenance over time of the restoration work described herein. The Parties recognize and agree that the Conservation Easement may confer additional access and/or other rights on the Conservancy and its officers, employees, contractors, and agents, and this MOU shall not be interpreted to limit or impair any such rights.

- **8.** <u>Liens</u>. The Conservancy shall not permit to be placed against the Property, or any part thereof, any mechanics', materialmen's, contractors' or subcontractors' liens with regard to the Conservancy's actions on the Property. The Conservancy agrees to hold the County harmless for any loss or expense, including reasonable attorneys' fees and costs, arising from any such liens which might be filed against the Property.
- **Compliance with Laws/Permits**. The Conservancy shall, in all activities related to its use of the Property, comply and cause its agents, employees and volunteers to comply with all federal, state and local laws, statutes, orders, ordinances, rules, regulations, plans, policies and decrees. Without limiting the generality of the foregoing, the Conservancy, at its sole cost and expense, shall obtain any and all permits which may be required by any law, regulation or ordinance for any activities related to the Conservancy's use of the Property.
- **10.** Related Actions. The Parties agree to take all actions not described with particularly herein that may be reasonably necessary to effectuate the purpose of this MOU, as set forth in Section 1, above.
- 11. <u>Miscellaneous</u>. The release, assumption of risk, and indemnity provisions set forth in Sections 4-6, above, are intended to be as broad and inclusive as permitted by law and, if any provision of this MOU is held invalid, the balance shall continue in full legal force and effect. The invalid provision shall automatically be replaced by a substitute provision which is valid and as nearly as possible maintains the same purposes and intention of the invalid provision. This MOU shall be interpreted in accordance with the laws of the State of California.



REQUESTED ACTION:

1. Receive and file fiscal update

BACKGROUND:

As part of the Conservancy's regular financial updates to the Board, staff provides a fund-level financial report (Attachment A). This report includes year-to-date revenues and expenditures as of November 21, 2025 for the Mitigation Fee Fund (Fund 7230), Mitigation Trust Account Fund (Fund 7231), Grant Fund (Fund 7232), and Other Revenue Fund (Fund 7235) and year-to-date revenues and expenditures as of September 30, 2025 for the Pre-Permit Endowment Fund (Fund 7233) and Post-Permit Endowment Fund (7234). Funds associated with the Pre-Permit Endowment Fund and Post-Permit Endowment Fund are reported as of September 30, 2025 because they are primarily held by the Sacramento Region Community Foundation, which provides statements on a quarterly basis. All other fund accounts are held by the County Treasury and are reported as of the most recent date that Conservancy staff requested fund information from County Finance staff. A summary of the status of each fund is provided below.

Mitigation Fee Fund (Fund 7230)

This fund is the primary fund for revenues and expenditures associated with implementation of the Yolo HCP/NCCP. Both revenue and expenditures in the Mitigation Fee Fund are under budget year-to-date. Staff anticipate a significant increase in fee revenue as larger projects seek Yolo HCP/NCCP coverage by the end of the fiscal year. The approved FY25/26 budget assumes that the Conservancy would be primarily staffed by County staff. Since there were no County staff filling Conservancy staff roles in the first five months of the fiscal year, there are no County office expenses, IT expenses, or transportation and travel expenses to-date and professional services that include administrative services are significantly lower than budgeted. The largest anticipated expenditure budgeted for this fund is the purchase of a conservation easement, which is anticipated to close in December and will be reflected in the mid-year budget update.

Mitigation Trust Account Fund (Fund 7231)

This fund holds mitigation funds collected by the Conservancy that are not tied to the Yolo HCP/NCCP. Currently this fund holds pre-permit mitigation funds that are to be used specifically for the conservation of burrowing owl habitat and accrued interest. These funds are budgeted to be used entirely within FY25/26 for a portion of a conservation easement purchase that is anticipated to close in December.

Grant Fund (Fund 7232)

This fund is designated for grant funds. The Conservancy did not have any active grants or known grant awards at the beginning of FY25/26 so no funds are currently budgeted in this fund and none have been expended during the fiscal year to-date.

Pre-Permit Endowment Fund (Fund 7233)

This fund holds endowment funding for pre-permit easement sites that were established prior to the implementation of the Yolo HCP/NCCP. The approximately \$13,735 in revenue reported as of September 30, 2025 in the Pre-Permit Endowment Fund is entirely interest earned on endowment account investments. Approximately \$1,091 in expenditures reported as of September 30, 2025 are fees charged by the Sacramento Region Community Foundation for holding and investing the funds. The Conservancy anticipates reporting expenditures associated with annual easement compliance monitoring conducted by the Yolo Land Trust will be reported in the next fiscal update.

Post-Permit Endowment Fund (Fund 7234)

This fund holds the Yolo HCP/NCCP's post-endowment funding. The approximately \$11,503 in revenue reported includes approximately \$815 in HCP/NCCP fees that were collected and deposited into the Post-Permit Endowment Fund according to the currently approved HCP/NCCP fee fund allocation and approximately \$10,688 of interest earned. Approximately \$771 in expenditures reported as of September 30, 2025 are fees charged by the Sacramento Region Community Foundation for holding and investing the funds.

Other Revenue Fund (Fund 7235)

This fund holds Special Participating Entity Fee revenue and other funds collected by the Conservancy that do not fit into the criteria for the other fund categories. No expenditures from this fund were budgeted in the FY25/26 and none have occurred to-date. The approximately \$1,146 reported as income to this fund as of November 21, 2025 is interest earned.

REQUESTED ACTION:

1. Adopt the proposed Elderberry Transplant Entity Approval Policy

BACKGROUND:

Certain projects that have received Yolo County Habitat Conservation Plan/Natural Community Conservation Plan (Yolo HCP/NCCP) permit coverage and have mature elderberry (Sambucus mexicana) plants within their project footprint are required to transplant elderberry plants to a Yolo HCP/NCCP reserve system site. While the Yolo Habitat Conservancy is responsible for the management and monitoring of elderberry plants once they are planted at a reserve system site, the project proponent is responsible for securing the services of a contractor with previous experience relocating mature elderberry plants to transplant the plants from their project site to locations within the Yolo HCP/NCCP reserve system that are specified by the Yolo Habitat Conservancy.

In an effort to help ensure mitigation success and to be able to provide a list of experienced entities that can be utilized as a resource by project proponents, Conservancy staff recommend that the Board adopt the Yolo HCP/NCCP Elderberry Transplant Entity Approval Policy (Attachment A).

DRAFT Yolo HCP/NCCP Elderberry Transplant Entity Approval Policy

Provided to the Yolo Habitat Conservancy Board for Adoption: December 8, 2025

1. PURPOSE

Some development projects covered by the Yolo Habitat Conservation Plan/Natural Community Conservation Plan (Yolo HCP/NCCP) require the transplanting of mature elderberry shrubs from the covered project site to a Yolo HCP/NCCP reserve system site. It is the responsibility of project proponents seeking coverage under the HCP/NCCP to secure the services of an entity qualified to transplant elderberry shrubs from their project site to a Yolo HCP/NCCP reserve system site. In an effort to both ensure the survival and overall health of mature elderberry shrubs that are transplanted as a result of projects covered by the Yolo HCP/NCCP and to provide project proponents with a list of contractors eligible to transplant mature elderberry shrubs, the Yolo Habitat Conservancy (Conservancy) is establishing a list of contractors that have demonstrated that they have the experience and qualifications to transplant elderberry shrubs. In order to be considered for inclusion on the list of qualified elderberry transplant entities, a contractor must submit a qualified elderberry transplant entity application to the Conservancy.

2. SCOPE

This policy applies to all public and private project proponents who have or seek to receive Yolo County Habitat Conservation Plan/Natural Community Conservation Plan (Yolo HCP/NCCP) permit coverage and have mature elderberry (*Sambucus mexicana*) plants within their project footprint and are required to transplant elderberry plants to a Yolo HCP/NCCP reserve system site.

3. POLICY

Project proponents that intend to have elderberry plants transplanted to a Yolo HCP/NCCP reserve system site are required to utilize the services of an individual or entity that has been approved by the Conservancy to transplant mature elderberry plants. To be considered for inclusion on the list of qualified elderberry transplant entities, an individual or entity must submit a qualified elderberry transplant entity application to the Conservancy that demonstrates that they have experience successfully transplanting large elderberry shrubs and/or other applicable qualifications. The Conservancy will evaluate the qualifications of applicants based on the information provided in the application and may also utilize input from references provided and information from other readily available sources. Applications will be accepted on a rolling basis, and the Conservancy reserves the right to utilize it sole discretion to approve, reject, or request additional information from any applicant. Application materials and the list of approved elderberry transplant entities will be made available on the Conservancy's website.

REQUESTED ACTION:

BACKGROUND:

The California Department of Fish and Wildlife (CDFW) administers a grant program called the Natural Community Conservation Planning (NCCP) Local Assistance Grant (LAG) Program. CDFW awards grants under the LAG Program on a competitive basis to eligible applicants on an annual basis for high priority tasks needed to implement NCCPs. The Conservancy submitted a grant proposal in July 2025 to support the Conservancy's efforts to improve and increase habitat for burrowing owls in Yolo County. The proposed project includes the installation of 20 artificial burrows, at least 10 tunnel shelters, and restoration and enhancement of grassland prairie foraging habitat within the immediate vicinity of both natural and artificial burrow sites on 4 to 6 priority Yolo HCP/NCCP reserve sites in Yolo County. The Conservancy's proposal was selected to receive \$109,673 in LAG funds to implement the abovementioned project. Implementation of the project will help achieve Yolo HCP/NCCP Objective WBO1.5: Implement management and enhancement practices to encourage burrowing owl occupancy on preserve lands. Staff recommend that the Board approve a Resolution (Attachment A) to authorize the acceptance of grant funds and direct the Executive Director to execute a grant agreement with CDFW and take any necessary steps to implement activities related to the grant.

BACKGROUND:

The National Fish and Wildlife Foundation (NFWF) administers a grant program called the Monarch Butterfly and Pollinators Conservation Fund. NFWF offers these grants annually on a competitive basis for projects that enhance and restore habitat for monarch butterflies and other pollinators. The Yolo HCP/NCCP Plan Area is located within in an area that is considered a significant breeding area for monarch butterfly, is within the core habitat area for valley elderberry longhorn beetle (VELB) which is a Yolo HCP/NCCP covered species and is federally listed as threatened, and within the habitat range of Crotch's bumble bee which was recently designated as a candidate species for listing under the California Endangered Species Act.

The Conservancy submitted a proposal to NFWF to support the enhancement and restoration of riparian and grassland prairie habitat for butterflies, beetles, and bumble bees within existing and candidate Yolo HCP/NCCP reserve system sites. The project also includes the incorporation of pollinator habitat management practices into three HCP/NCCP reserve system site management plans, and outreach efforts to educate the public about habitat conservation and the importance of pollinators and their habitats. Implementation of the proposed project would help achieve Yolo HCP/NCCP Objective L-2.2: Increase the abundance of native insect pollinators that support reproduction of native plant species, and Objective VELB1.2: Within the restored valley foothill riparian natural community, establish elderberry shrubs and associated riparian plant species, and prioritize lands adjacent to existing populations [of valley elderberry longhorn beetle] to provide for population expansion. The Conservancy's proposal was selected to receive \$260,000 in grant funds to implement the abovementioned project. Staff recommend

that the Board approve a Resolution (Attachment A) to authorize the acceptance of grant funds and direct the Executive Director to execute a grant agreement with NFWF and take any necessary steps to implement activities related to the grant.

BACKGROUND:

The Conservancy Board approved the Fiscal Year 2025-2026 Budget on May 19, 2025. At that time, the fund appropriation for the Grant Fund was approved at \$0 since the Conservancy did not have any active or awarded grants at the time. The Conservancy was subsequently awarded \$109,673 in grant funding from the California Department of Fish and Wildlife's Local Assistance Grant Program and \$260,000 in grant funding from the National Fish and Wildlife Foundation's Monarch Butterfly and Pollinators Conservation Fund to implement activities that support implementation of the Yolo Habitat Conservation Plan/Natural Community Conservation Plan Conservation Strategy. These grants will be effective for approximately two years. Funds for both of these grant programs are available on a reimbursement basis and will be available starting in early 2026. Staff recommend that the Board approve the Resolution (Attachment A) to authorize and direct the County's Chief Financial Officer to amend the Conservancy's Grant Fund budget for fiscal year 2025-2026 to allot an appropriation and revenue increase of \$110,000 such that the Conservancy can utilize a portion of the awarded grant funds during the second half of fiscal year 2025-2026.
